

Activities and Achievements of Panchayati Raj & Drinking Water Department for September 2018 during the year 2018-19

The Panchayati Raj & Drinking Water Department has been entrusted with implementation of various Poverty Alleviation Programmes in the State. The Poverty Alleviation Programmes mainly cater to the needs of rural families living below the poverty line. These Programmes can be grouped under the following five broad categories:-

1. Self Employment Programme

National Rural Livelihood Mission (NRLM) :-

During the current financial year 2018-19 up to September 2018, an amount of ₹14036.21 lakh has been utilized against the total available funds of ₹23763.64 lakh. The Percentage of utilization is 59%. 39051 numbers of SHGs have been Credit linked against the total target of 1, 35,000 numbers of SHGs.

As compared to this, an amount of ₹12620.41 lakh was utilized in the corresponding period of the previous year 2017-18 out of total available funds of ₹17809.95 lakh. The utilization of fund is 71% and 31329 numbers of SHGs was credit linked against the total target of 80,000 SHGs.

In scheduled areas, up to September 2018 in the current financial year 2018-19 an amount of ₹2836.44 lakh has been utilized out of total available funds of ₹5995.43 lakh. The utilization of fund is 47% and 9026 numbers of SHGs have been credit linked against the total target of 31,651 SHGs

2. Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS):-

During the current financial year 2018-19 up to September 2018 an amount of ₹135752.15 lakh has been utilized against the total available funds of ₹139015.26 lakh. The utilization of fund is 98%. 504.99 lakhs person days have been generated against the target of 950.00 lakhs.

As compared to this, an amount of ₹137909.48 lakh was utilized in the corresponding period of the previous year 2017-18 out of available funds of ₹138766.99 lakh. The utilization of fund was 99%. 461.09 lakh person days were generated against the target of 900.00 lakhs.

In scheduled areas, up to September 2018 in the current financial year 2018-19, an amount of ₹64267.31 lakh has been utilized against the total available funds of ₹64650.56 lakh. The utilization of fund is 99% and 229.15 lakh person days have been generated against the target of 375.41 lakh.

3. Gopabandhu Garmin Yojana (GGY):-

It provides additional developmental assistance in all the districts of the State. The principal objective is to provide rural infrastructure primarily Bijli, Sadak & Pani to every revenue village in the districts.

It is a State plan scheme launched in 2006-07 and the entire fund is provided by the State Government.

Expenditure to the tune of ₹14375.96 lakh has been incurred in the current financial year 2018-19 up to September 2018 against the available funds of ₹75287.35 lakh, which constitutes 19%. 5985 number of houses were completed against the target of 14221.

As compared to this, ₹20771.71 lakh was utilized out of total available funds of ₹39665.38 lakh in the corresponding period of the previous year 2017-18, which constituted 52%. 9702 no. of works were completed against the target 17645.

In scheduled areas, up to September 2018 in the current financial year 2018-19, an amount of ₹ 3236.91 lakh has been utilized against the total available funds of ₹26201.31 lakh. The utilization of fund is 12%. 1415 no. of works are completed against the target of 4253.
