**SELECTION OF AGENCY/FIRMS FOR ESTABLISHMENT AND OPERATION OF  
GRIEVANCE MANAGEMENT SYSTEM THROUGH CALL CENTRE**

The Engineer-in-Chief, RWSS, on behalf of Panchayati Raj & Drinking Water Department, Government of Odisha invites Request for Proposal (RFP) from interested Agency / Firms to Establish and Operate Call Centre (both Inbound & Outbound mode) for Operation of Grievance Management System on outsourced model for Rural Drinking Water schemes of Odisha.

The eligibility criteria for selection of Agency/Firms are provided below:

- 1) A company incorporated under Indian Companies Act, 1956 or a Firm registered under Partnership Act, 1932 or Sole Proprietorship.
- 2) The applicant company/firm must have been in providing services of similar work at least 3 years prior to the due date of submission of the RFP. Relevant experience certificate or proof of operating call centre 3 years prior to the due date of RFP must be furnished.
- 3) The Average Annual Turnover (**from Operation of Call Centre**) of the applicant during last 3 financial years (FY 2014-15, 2015-16 & 2016-17) shall be more than **Rs. 5.00 Crores**. A certificate from Chartered Accountant specifying the total turnover of the company and turnover from similar works must be attached in the Proposal.
- 4) The applicant must have a registered agency / firm by any Government Organisation in India. A copy of the Registration Certificate to be furnished in the RFP proposal
