Sub:- Ensuring proper implementation of the projects like Kalyan Mandap, Market Complex, improvement of GP Ghar etc. as well as repair and maintenance of Roads including Bridges and culverts.

Madam/ Sir,

In inviting a reference to the subject cited above, it is to bring to your notice that, huge funds under 4th State Finance Commission Grant have been released to the Grama Panchayats for creation of income generating assets like Kalyan Mandap, Market Complex, improvement of GP Ghar, Rural Hat etc. and also for construction of VLW Quarters in the Grama Panchayats. The district-wise numbers of projects allotted is enclosed herewith for reference at Annexure - "A" and "B".

Further, it is to say that as on today, it is not clear about the progress of such construction works in different Grama Panchayats as many issues like technical sanction of estimates, identification of sites and issue of work orders are neither ensured by the BDOs nor reviewed by the Project Directors, DRDAs. Unless and until the funds allotted in the year 2015-16 are exhausted, Government is in a dilemma as to how to release funds and ensure progress of works in 2016-17.

Since this allocation is separate from the Devolution of Funds of CFC and SFC which are meant for Basic Civic Services, this is to be reviewed separately which will boost the infrastructural development in rural areas.

You are, therefore, requested to review the following issues in the monthly review meeting of the BDOs and furnish a report with your views to this Department by 30th September, 2016 for information and examination at Government level.

1. The Project Directors, DRDAs and BDOs to supervise and monitor, implementation and completion of the projects in right time and also share the photographs of the completed projects through WHATSAPP for information of all officers.
2. The field visit programme of Block level officials and DRDA level officials including Addl. Project Director (Tech.) are to be streamlined so that, the distant unreached villages/ habitations are covered in every month to ensure proper implementation of plans and programmes of Government in those areas. The missing links and gaps felt in proper communication facility shall be sorted out while preparing the Action Plan at Zilla Parishad level, Block level and Grama Panchayat level.

This may be given "**Top Priority**" in the monthly review meeting.
