





**TERMS & CONDITIONS OF ENGAGEMENT OF
CONSULTANT(MONITORING & EVALUATION)**

Eligibility Criteria

- He should have professional excellence in Govt. assignments, good service records, physically & mentally fit for engagement after retirement on superannuation.
- He should have retired from Govt. Service on attaining the age of superannuation & below the age of 63 years.
- Officers against whom departmental proceedings or vigilance/criminal cases contemplated/ pending or who have been penalized for mis-conduct during preceding five years of service period shall not be considered.

Selection Methodology

- Selection of short-listed candidates shall be made through Personal Interview by the Selection Committee.
- No TA/DA for to & fro journey will be paid either for attending the personal interview or joining the post in Rural Housing Section of Panchayati Raj & Drinking Water Department.
- This Department reserves the right to cancel either the whole selection process or of any candidature without assigning any reason thereof.

Terms of Engagement

- She/He will be engaged in Rural Housing Section, PR&DW Department for a period of one year subject to further extension based on satisfactory performance / requirement of Rural Housing Section, PR&DW Department.
